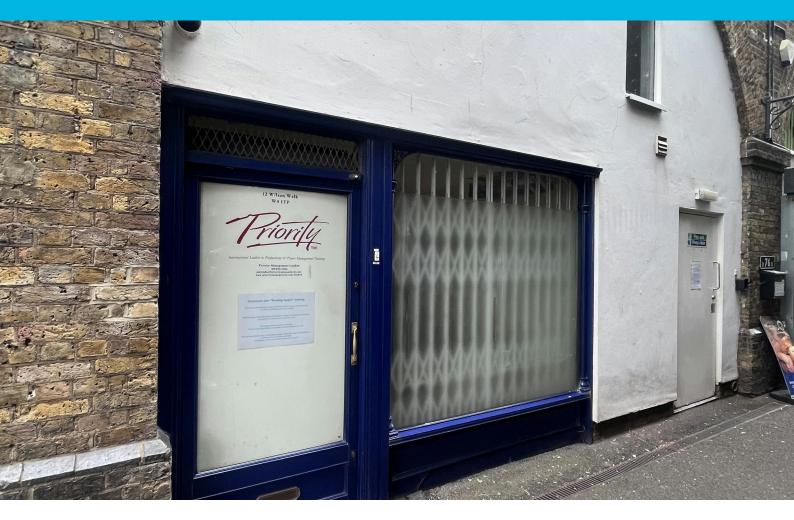

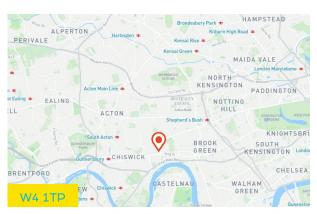

The property comprises one arch unit, Arch 194, which has been fitted out to be used as an office premises. The arch benefits from being fit out to serve as an office usage. There is water supply, a fitted kitchen, and WC. The arch has a full concrete facia to both the front and rear with pedestrian access doors, including a fire exit door to the rear. Surrounding occupiers include coffee shops, gyms, creative spaces, and various other small businesses.

Arch 194 lies along Wilson Walk, a short run of arches that lead to Stamford Brook Underground Station. The unit is within close proximity to Stamford Brook Underground Station (Zone 2) which is served by the District Line. It lies under 100m from the arch.
