



DESCRIPTION

Arch 222 comprises an exposed brick arch unit suitable for light industrial/storage uses. The main access to the unit is via a double steel hinged door to provide vehicular access with a separate single steel hinged door to the rear. The curvature starts at 1.35m extending to 4m at the apex. The height of the access door reaches 3.5m point to point. The unit benefits from WC facilities and a power supply of 150 rev–KwH, 240v and 50 Hz.

LOCATION

The arches are located equal distance between Goldhawk Road and Hammersmith tube stations (Circle and Hammersmith & City) approximately 4 minutes walk away. Access by vehicle can be gained from Goldhawk Road which gives access to Hammersmith Road and then to Trussley Road.
